In the last decade, globally, countries have seen an increase on victims that need to be addressed from multidisciplinary and multi-sectorial approaches.

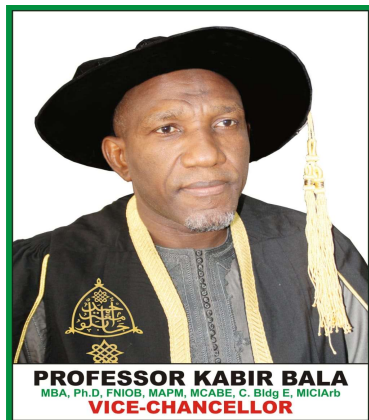
Africa has seen an increase in the spectrum of criminal activities and the number of murders, suicide, human trafficking, terrorist attacks, abductions, civil strife, displacements and other disorder previously not experienced in many countries in Africa. This has led to the continent having more victims than ever before. In general terms **“A victim shall mean any individual, group or legal entity having suffered harm as a result of violation”**.

Sustainable Development Goal (SDG 16) is focused on Peace, Justice and Strong Institutions. Agenda 2063, The Africa We Want, Aspiration 3 talks of Africa of good governance, democracy, and respect for human rights, justice and the rule of law. In some countries, policies and legal structures protecting victims are also available, for example in Kenya, there is the Kenya Victim Protection Act (2014) which lays emphasis on crime victims and the same is also replicated in other developing Countries. Although criminal justice is typically focused on role of accused persons, the trend in international criminal justice is increasingly focused on victims’ needs.

This Conference focus is on victim assistance and protection deficiencies which in most countries in have been hampered by lack of adequate knowledge, skills and awareness about victim support related issues by decision makers, policy and legal frameworks and lack of understanding on Human Rights and guiding principles.
