a B.Ed Technology all from Moi University. He is a registered Professional Engineering Technologist and a Fellow Member of the Institution of Engineering Technology of Kenya (FIET-K).

He has experience of over 27 years in the TVET sector having taught in various TVET institutions and universities in Kenya as well as consulting for public and private sectors in the East Africa region. He also has in-depth knowledge of TVET policy formulation and implementation, Competence-Based Training, Assessment and Certification (CBTAC), TVET regulations, project monitoring and
